NOTIFICATION

In exercise of powers conferred under sub section (1) of Section 8 of Factories Act, 1948 and in supersession of the orders issued vide G.O.Ms.No.31, LET&F (Lab.II) Department, Dt.5.6.1997 & G.O.Ms.No.50, LET&F (Lab.II) Department, Dt.26.8.99 and G.O.Ms.No.30, LET&F (Labour.I) Department, Dt.09.06. 2016, the realignment of jurisdictions as per New Districts under Factories Act,1948 (Central Act 63 of 1948) in respect of (i) Joint Chief Inspector of Factories (ii) Deputy Chief Inspector of Factories; (iii) Inspector of Factories and (iv) Assistant Inspector of Factories in the State subject to following exceptions namely:

- i. that the Inspector shall not have power to add amend vary or rescind any orders previously passed by him but if he considers that any such action is necessary or desirable he may do so after getting specific orders from Director of Factories and;
