### **Sub: Empanelment of Backoffice vendors**

This is with reference to Exchange Circular Ref. No: NSE/COMP/53088 dated July 26, 2022, and NSE/COMP/54706 dated December 02, 2022, on "Empanelment of Backoffice vendors" wherein Members were informed about the procedure for empanelment of Backoffice vendors with the Exchange.
