NOMINATION FOR ELIGIBLE DEMAT ACCOUNTS

DPs are advised to refer to CDSL Communique no CDSL/OPS/DP/POLCY/2023/49 dated January 20, 2023, regarding Nomination for Eligible Trading and Demat Accounts wherein we have informed DPs to take note that all existing eligible demat account holder/s shall provide choice of

nomination as per the option given in paragraph 2 of SEBI circular dated July 23, 2021.

DPs are reiterated to take note that all existing eligible demat account holder/s shall provide **choice of nomination** as per the option given in paragraph 2 of SEBI circular dated July 23, 2021, on or

before March 31, 2023, falling which the demat account shall be frozen for debits.

In this regard DPs are hereby informed that without the consent of BOs for choice of nomination DPs should not update the same as opting out of nomination. If found DPs are updating the 'choice of nomination' without the explicit consent of the investor it will be against the objective of the circulars and the same would be viewed seriously. This requirement emanates from regulatory

requirement and hence no fee may be charged for the same.

DPs are advised to take note of the same and ensure compliance.
