NOTIFICATION

In the light of amendment to The Karnataka Motor Vehicles Taxation Act 1957 vide Notification No. DPAL 21 SHASANA 2024, Dated:07.03.2024 The Government Notification No. SARIE 76 SAEPA 2016, dated:31.03.2016 Regarding Tax Exemption to Electric Vehicles is hereby revised with effect from 07.03.2024 as Follows;

“In exercise of the powers conferred by sub-section (1) of Section 16 of the Karnataka Motor Vehicles Taxation Act, 1957 (Karnataka Act 35 of 1957) the Government of Karnataka being of the opinion that it is necessary in public interest to do so hereby exempts from payments of taxes on all electric non-transport and transport vehicles including e-rickshaws and e-carts except for Motor cars, Jeeps, Omni Buses and Private Service Vehicles run on Electricity having cost of the vehicle which exceeds Rs.25.00 Lakhs & Tax are levied under column 7 of Part-A5 of the KMVT ACT 1957.”
