WHEREAS, the draft rules further to amend the Kerala Factories Rules, 1957 were published as required under section 115 of the Factories Act, 1948 (Central Act 63 of 1948) vide notification No. B2/72/2024/LBRD dated 31st August, 2024 in the



Kerala Gazette Extraordinary No. 2815 dated 3rd September, 2024 inviting objections or suggestions from all persons likely to be affected thereby:

AND WHEREAS, the objections and suggestions received from the public in respect of the said draft rules have been considered by the Government;

NOW, THEREFORE, in exercise of the powers conferred by section 112 of the Factories Act, 1948 (Central Act 63 of 1948), the Government of Kerala hereby make the following rules further to amend the Kerala Factories Rules, 1957, namely:-

RULES

- 1. Short title and commencement— (1) These rules may be called the Kerala Factories (Amendment) Rules, 2024.
 - (2) They shall come into force at once.
- 2. Amendment of the Rules. In the Kerala Factories Rules, 1957,-

In sub rule (5) of rule 7, for the figures and words "5 years", the figures and words "10 years" shall be substituted.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.) As part of Business Reforms Action Plan 2024, Government have decided to allow the validity of license under the Factories Act, 1948 to be 10 years. Hence it has been decided to amend Kerala Factories Rules, 1957 accordingly after considering the objections and suggestions received from the public in respect of the draft rules published as per notification No. B2/72/2024/LBR dated 31st August, 2024 in the Kerala Gazette Extraordinary No. 2815 dated 3rd September, 2024.

The notification is intended to achieve the above object.
