## AMENDMENTS TO DP OPERATING INSTRUCTIONS CHAPTER-2

DPs are advised to note that amendments have been incorporated in CDSL's DP Operating Instructions Chapter Chapter 2-Account Opening, sub clause 2.3.4.2 based on SEBI Circular no. SEBI/HO/MRD/MRD-POD-2/P/CIR/2022/114 dated August 26, 2022 that is "In the event of the death of the Karta of HUF, the name of the deceased Karta in the Beneficial Owner (BO) account shall be replaced by the new Karta of the HUF who in such a case shall be eldest coparcener in the HUF or a coparcener who is appointed as Karta by an agreement reached amongst all the coparceners of the HUF".

The proposed amendments to the DP Operating Instructions are given in track changes mode [ Refer Annexure - A].
