In exercise of the powers conferred by sub-section (1) of section 40 of the Motor Transport Workers Act, 1961 (Central Act 27 of 1961), the Government of Kerala, hereby make the following rules further to amend the Kerala Motor Transport Workers' Rules, 1962, the same having been previously published as notification No.LBRD-E3/63/2023-LBRD dated 22<sup>nd</sup> July, 2024 in the Kerala Gazette Extraordinary No. 2414 dated 26<sup>th</sup> July, 2024 as required under sub-section (1) of section 40 of the said Act, namely:-



## RULES

1. *Short title and commencement.*- (1) These rules may be called the Kerala Motor Transport Workers' (Amendment) Rules, 2025.

(2) They shall come into force at once.

2. *Amendment of the Rules.*- In the Kerala Motor Transport Workers' Rules, 1962, in rule 5, for the existing Table, the following Table shall be substituted, namely:

### **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

As per Rule 5 of the Kerala Motor Transport Workers' Rules, 1962, a Certificate of Registration for an undertaking shall be granted by the Chief Inspector or an Inspector duly authorised by him in this behalf in Form No. II on payment of fees as specified. The Government have amended the above said Rule and revised the rate of fees payable for the grant of Certificate of Registration vide Notifications issued under G.O.(P) No.84/2013/LBR dated 16<sup>th</sup> July, 2013 published as S.R.O No.570/2013 in the Kerala Gazette Extraordinary No.2155 dated 23<sup>rd</sup> July, 2013 and G.O.(P) No. 133/2014/LBR dated 29<sup>th</sup> October, 2014 published as S.R.O. No.752/2014 in the Kerala Gazette Extraordinary No.2957 dated 3<sup>rd</sup> December, 2014. Now the Government have decided, further to amend the Rule 5 of the above said rule and to revise the rate of fees mentioned in the said rule shown as above.

The notification is intended to achieve the above object.
