No. Elec-2023/IR-II/PSCE/Hol/ 14677 Whereas, the State Election Commission, Haryana issued a notification no. SEC/4E-II/2023/1131 dated 23.05.2023 for holding a poll on 15.06.2023 (Thursday) for the post of Panches and Sarpach of Gram Panchayat Sambhalkha, Block Ladwa, District Kurukshetra.

And whereas, it is considered necessary to provide opportunity to all the workers/employees working in all Shops and Commercial Establishments to exercise their franchise.

Now, therefore, in exercise of the powers conferred by Section 28 of the Punjab Shops and Commercial Establishments Act, 1958 (Punjab Act 15 of 1958) and all other enabling powers, the Governor of Haryana hereby fixes 'Thursday' the 15.06.2023 for the above jurisdiction to be the holidays with wages for all the workers/employees enrolled as voters in Gram Panchayat Sambhalkha, Block Ladwa, District Kurukshetra working in all the shops and commercial establishments within the State of Haryana to enable them to cast their votes.





**Notification**

**No. F.W./Election-2023/466.**— Whereas the General Elections of Gram Panchayat Sambhalkha, Block Ladwa, District Kurukshetra for which poll shall be held on the 15.06.2023 (Thursday) as per letter of the State Election Commission, Haryana issued *vide* No. SEC/4E-II/2023/1155-1156 dated 23.05.2023.

And whereas, it has been considered necessary to provide opportunity to the public to exercise their franchise.

Now, therefore, in exercise of the powers conferred by Sub-section (2) of Section 65 of the Factories Act, 1948 (Central Act 63 of 1948) and all other powers enabling him in this behalf, the Governor of Haryana is pleased to exempt only those workers who are working in the Factories in the State of Haryana and are enrolled as the voters where General Elections of Gram Panchayat Sambhalkha, Block Ladwa, District Kurukshetra for which poll shall be held on the 15.06.2023 (Thursday) from the operations of provisions of Sub-section (1) of Section 52 of the said Act, for the week commencing from 18.06.2023 and ending on 24.06.2023, subject to the condition that no adult worker who is enrolled as voter in election to Gram Panchayat Sambhalkha, Block Ladwa, District Kurukshetra shall be required or allowed to work on 15.06.2023 (Thursday) in the factories of the state of Haryana.
