NOTIFICATION

No.TMV/E 332990/16.- The following certain rules further to amend the Assam Motor Vehicle Rules, 2003, hereinafter referred to as the principal Rules, which the Governor of Assam proposes to make in exercise of the powers conferred by section 96 and section 207 of the Motor Vehicles Act, 1988 (Central Act No. 59 of 1988) were published as required under sub-section (1) of section 212 of the said Act vide Government Notification No.E.TMV/E 332990/11, dated.10.07.2023 in the Assam Gazette Extraordinary No.307, dated.12.07.2023 inviting objections or suggestions from any person likely to be affected thereby within a period of 07 (seven) days from the date of publication in the Official Gazette;

And whereas no objections and suggestions were received from any individual or organisations with respect of the said rules before the expiry of the period specified above for consideration by the Governor of Assam.

Now, therefore in exercise of the powers conferred by section 96 and section 207 of the Motor Vehicles Act, 1988, the Governor of Assam is hereby pleased to make the following rules, namely;-

Short title and 1. (1) These commencement (Ame

These rules may be called the Assam Motor Vehicle (Amendment) Rules, 2023.

(2) They shall come into force on the date of their publication in the Official Gazette.

Amendment of 2. In the principal Rules, in rule 25, for sub-rule (3), the following shall be substituted, namely:-

Amendment of 3. In the principal Rules, in rule 46(B), after sub rule (h), the following sub-rules (i) and (j) shall be inserted, namely:-

- "(i) -Late Fine In case of delay in renewal of any type of permit, late fine for an amount of Rs. 50/- per day shall be levied from the date of commencement of this rule.
 - (j) Fee for Two-wheeler bike Tax (Within the State)

Amendment of rule 112

In the principal Rules, in rule 112, for sub-rule (3),the following shall be substituted namely:-

"(3) These licences shall be in force for five years and thereafter may be renewed for another five years on an application to the Licensing Authority which granted the licence not less than six days before the date of expiry. In case of non-renewal of licence in time a fine of Rs. 50/- per day shall be imposed."
